



## Martin Complex For the Elderly Near Completion

Town Center Plaza, the town of Martin's 28-apartment complex especially designed and built for the elderly, will have its final inspection tomorrow (Thursday) and will be available to tenants immediately thereafter, it was announced Monday by Helen P. Hoon, executive director of the Martin Housing for the Elderly Commission.

The \$75,542 housing project is located at the rear of the municipal parking lot and consists of two separate structures, each of two stories. Of the 28 apartments provided for the elderly, 18 are efficiency apartments for single occupants, with three of these for the handicapped, and 10 are one-bedroom apartments for couples. The complex includes a community room and a laundry room for the convenience of tenants.

Town Center Plaza is the first housing facility constructed in the area especially for the elderly. It and the Pageant Hills development give the community 68 housing units.

Construction was done by Bradley & Powers, Paintsville contractors, who began work on the project in December, 1973.

## Work This Year To Repair Third Of Roof Damage

The cost of repairing roofs, eavestroughs and downspouts of Floyd county school property, including the administrative building here, will be an estimated \$196,000, and the Floyd County Board of Education does not have the money for the full repair undertaking.

That dilemma confronted the board of education at its meeting last Saturday when Walter Price, of the Washington Roofing and Sheet Metal Co., Huntington, W. Va., reported his findings after a survey authorized recently by the board.

After a lengthy discussion of the knotty question, the board directed Superintendent of Schools Charles Clark to meet with Forrest McCloskey, Lexington architect, decide which buildings most urgently need such repair, and then perhaps in this year a third of the total work suggested by Price.

At the same time, the board authorized the superintendent to file a BG1 (the first step required for Division of Buildings and Grounds approval of a project). Mr. Clark said he would meet with the architect this week.

The board of education approved the school calendar adopted by a committee composed of directors of the Floyd County Teachers Association, members of the Attendance Department and Superintendent Clark. The calendar, as usual, provides for 180 teaching days, but schools will open for the 1975-76 school year on Aug. 23, a week later than usual. The usual spring vacation, which historically coincides with state basketball tournament time, was eliminated, and the only extended holiday will be Christmas week. One-day holidays will be Labor Day, Thanksgiving and New Year's. If there is no lost time, the term will end next May 17.

## Flood Insurance, Annex Job OK'd

### Contract Seen On Courthouse Work in August

The Floyd fiscal court Monday afternoon voted compliance with the National Flood Insurance Act and approved plans for the construction of a courthouse annex as a juvenile detention center.

Both moves had been under consideration for months as federal law on the one hand demanded flood insurance and the Court of Appeals on the other called for separation of juvenile prisoners from sight and sound of older persons held prisoner.

The court had hesitated to comply with the flood insurance law because it did not want to assume the task of zoning. And its action Monday still does not provide for zoning, although a U. S. Corps of Engineers map of flood-prone areas will control new construction sites, and a building inspector will perhaps be required.

In fact, the mapping provided is regarded as to incomplete and erroneous in some instances that early compliance with the Flood Control Act was urged in order to give the fiscal court time to lodge protests against inequities which may result from hasty and admittedly inaccurate mapping.

Had the court refused to comply with the federal flood insurance act, all loans for construction from financial institutions operating under the Federal

## The Question Asked: If No More Toll Road Work, Will KY 80 Get Needed Funds?

The opening of the Daniel Boone Parkway, Kentucky's newest toll road, and the almost simultaneous freeing of the Kentucky Turnpike from further tolls, poses the question:

"Will Kentucky build other toll roads?"

And, if the answer is no, as some predict, another question rises:

"Then how can KY 80 from US 23 to the Daniel Boone Parkway at Hazard ever be improved?"

Governor Carroll recently told a Hazard audience that KY 80 must be rebuilt—if the state can find the money. He is said to oppose another toll road unless it can be financially justified. His thinking, it is said, is that some other way can be found to finance KY 80.

U. S. Senator Wendell H. Ford sought while he was governor to get Appalachian Regional Commission help, but failed. KY 80 was a "firm commitment" of Ford's, and before he left office preliminary engineering on the route began. Whether he can be more successful with ARC as a U. S. senator than as Kentucky governor is an unanswered question.

Although the Kentucky Turnpike paid out, ahead of schedule, none of the others, including the Mountain Parkway,

is expected to pay its way. That means the deficit must be made up from the state's general fund.

But the toll road system began when Gov. Bert Condon's advisers told him, 15 years ago, that the state had only the choice of "toll roads or no roads." The Mountains as well as the Blue Grass and western Kentucky benefited from a splendid highway system.

Although most financial analysts are pessimistic about the toll road picture, not so Richard Nolan, coordinator for the highways committee, Legislative Research Commission. He has a graph which on the face of it makes the road fund picture very bright, indeed. Projecting through the year 2010 when the last toll road debt will be due for retirement, Nolan puts the road fund at \$1.3 billion, and that is \$850 million more than will be required to retire the toll road bonds.

On the basis of this argument, more money can safely be made available for more toll roads.

And in such reasoning, some say, lies the hope for KY 80, a link between US 23 and the Boone Parkway which needs all the traffic in sight to make it self-supporting.

## Coal Company Claims Sales Loss, \$132,000

A Floyd county coal company filed suit in circuit court here Monday seeking to recover from its market outlet a total of \$132,000.

The R & V Coal Company claims it entered into contract with the Mari Fuel & Processing Company last August 30 to deliver to the Elkhorn No. 3 seam of coal on the Buckeye fork of Middle Creek which Mari had sub-leased. The agreed price, plaintiff claims, was \$14 a ton for coal delivered to defendant's tipple at Permele, near David, defendant to pay all severance taxes, engineering fees, UMW dues and royalties.

The coal company claims it mined and delivered 30,000 tons of coal but was paid only \$12 a ton, and claims on that score \$60,000 loss.

On May 15, the suit adds, the defendant firm advised drivers hauling the coal to the tipple not to deliver any more, and since that time has refused to accept any coal from the plaintiff. Production of the mine at that time, and since, averaged 450 tons a day, and plaintiff was making a profit of \$4 a ton, the complaint claims. Plaintiff says it would have delivered 13,500 tons since the cutoff May 15 and would have realized a profit of \$54,000. It adds that, prior to the May 15 refusal to accept more coal, there were at least 10 one-day periods when coal was refused. For this an additional \$18,000 was claimed.

(Information in such suits represents only the statements of plaintiffs.)

## Floyd, Magoffin Work To Cost \$1.8 Million

A \$340,200 contract award for road improvements in Floyd county has been announced by state Secretary of Transportation John C. Roberts.

The contract, which was awarded to the East Kentucky Paving Corp., Grayson, calls for blacktopping the following:

The Pumping Station road from the old Allen-Prestonsburg road (CR 1070) and extending north for a distance of approximately 4 miles; The Mare Creek road from US 23 and extending east to the existing blacktop for a distance of approximately 7 miles; Poplar Street in Boldman from Old US 23 to Fourth Street, a distance of approximately 2 miles; Old US 23 in Boldman from the Barricade and extending east to the existing new surface for a distance of nearly 1 mile; Fourth Avenue in Boldman from Poplar Street and extending to

Main Street for a distance of approximately 1 mile; Third Avenue in Boldman from Poplar Street to Main Street for a distance of approximately 2 miles; Main Street in Boldman from Fourth Avenue to Old US 23 for a distance of approximately 1 mile; Cherry Street in Boldman from Fourth Avenue to Old US 23 for a distance of approximately 1 mile; Second Avenue in Boldman from Poplar Street to Cherry Street for a distance of approximately 2 miles; First Avenue in Boldman from Poplar Street to Old US 23, a distance of approximately 3 miles; The Jacks Creek road (KY 1460) from KY 122 to the Knott county line, a distance of approximately 4.6 miles; The Maytown-Garrett road (KY 77) from approximately 3.3 miles south of KY 80 at Maytown and extending for two miles east of KY 80 at Garrett, a distance of approximately 3 miles; The Penhook Branch road from US 23 at Boldman and extending northeast for a distance of 4 miles; The East McDowell-Mud Creek road (KY 680) from KY 1929 at East McDowell to KY 979, a distance of approximately 4.6 miles.

A \$132,814 contract award for bridge improvements in Floyd and Johnson counties has also been announced.

The contract calls for repairs to the decks of the bridges over Johns Creek at the Floyd-Johnson county line and over the C&O railroad and the Big Sandy River. Both bridges are on the Paintsville-Prestonsburg road (US 23 and US 460).

The contract was awarded to All Points Construction Company, of Lexington.

Awarding of a contract for road improvements in Floyd and Magoffin counties was announced last week.

The contract calls for the blacktopping of the following roads:

—The Fredville-David Road (KY 404) from KY 7 to the Floyd county line, a distance of approximately 2.7 miles;

—The Salyersville-Royalton-Hindman road (KY 7) from KY 1471, near Swampton, to the Floyd county line, a distance of approximately 16.8 miles;

## Kroger To End 49-Year Stay Here, July 12

Kroger's, Prestonsburg's oldest grocery store, will close its doors with the end of business Saturday, July 12.

But its Court Street location may continue to be used as a retail food outlet, it was said this week. The building is owned by Ed Music and Truly Francis.

Kroger's came to Prestonsburg in the summer of 1926, opening in the Patton building on Court street. Two years later, the store moved into the present Hobbs building on First Avenue, later to the Elizabeth Hotel building and finally to the present location. For the first 22 years of the store's operation here Curtis W. May was its manager.

Charles Sturgill, the present store manager, said the 17 Kroger employees here will be given an opportunity to transfer to the new store which Kroger's is opening in a shopping center at the mouth of Cowpen, near Pikeville.

## Woman Waives Slaying Charge

Mrs. Mary Sue Couch Flanery, 23, who was jailed here June 30 on a murder charge after her husband, Kirby Lee Flanery, 23, had been shot and killed at his trailer-home on Buck's Branch, near Martin, waived examining trial Saturday and later executed \$10,000 bond to answer to grand jury action.

Clarence Martin, who was wounded the night of June 30 by a revolver shot allegedly fired by his wife, Naomi, had sufficiently recovered this week to return to his home at Drift in a Lexington hospital. His wife, who was jailed following the shooting, has been released.

## General Budget Set at \$460,172 For Fiscal Year

A county budget of \$460,172 for the new fiscal year, plus \$785,424 expected in revenue sharing funds, was approved last week by D. M. Magill, state finance officer.

The budget does not include any coal severance tax funds, since these revenues are dispensed to the counties from Frankfort.

Two main items of the regular budget were down from last fiscal year. The \$189,643 marked for general government was approximately \$12,000 less than in fiscal 1974-75, and the appropriation for highways was down from \$172,165 last year to \$146,384. Other items of the general budget:

Protection to person and property, \$26,000, an increase of about \$5,000 over last year; health and sanitation, \$3,600, hospital, charities and corrections, \$12,752; libraries and other educational activities, \$3,000; debt service, \$22,607; miscellaneous, \$72,476; forestry, \$2,900.

The revenue sharing budget's biggest single item is the \$655,261 marked for capital outlay, providing for the courthouse annex construction. Other items in this budget are:

Public safety, \$75,127; environmental protection, \$36,306; recreation, \$5,360; social services for the aged, \$2,000; financial administration, \$5,470.

Source of anticipated funds to meet the requirements of the general \$460,172 budget were listed as these:

Taxes, \$260,772; truck licenses, \$40,000; public utilities, \$25,000; excess fees, \$13,300; occupational licenses, \$5,000; road equipment rental, \$75,000; operators' licenses, \$1,900; strip mine permit fees, \$20,900; forestry, \$2,900; crude oil, \$500.



### DAV Service Units To Visit in Area

Fourteen Kentucky communities will be visited between July 21 and August 15 by the Disabled American Veterans (DAV) fleet of mobile field service units. Eighteen traveling DAV service offices, housed in specially equipped 25-foot GMC motor vans, are on a year-long nation-wide tour of the United States.

Purpose of the tour is to carry the many free services provided by the DAV to wartime disabled veterans and their dependents who live some distance away from Veterans' Administration regional offices. Qualified DAV national service officers, most of whom are Vietnam era disabled veterans, will be on board the field service units to assist wartime disabled veterans and their families in their claims for federal and state benefits to which they are entitled by law.

The field units will be in Paintsville, Aug. 5-6, and at Pikeville, Aug. 7-8.

The \$1,945,743 contract was awarded to the East Kentucky Paving Corporation, of Grayson

Another contract awarded the same company calls for blacktopping the Hault-Anna Road (KY 979) from 2 1/2 miles west of US 23 to the Branham's Creek road, a distance of approximately 5.2 miles, and the Betsy Layne-Ligon-Clear Creek Junction road (KY 979) from KY 124 to KY 980, a distance of approximately 11.5 miles. East Kentucky Paving's bid on these two roads was \$881,519.

The two contracts are a part of a \$23.4 million package of 129 contracts let by Kentucky Department of Transportation June 19. This was the largest number of contracts ever awarded by the state in a single letting.  
It will cost \$24,000 of the package comes from state funds, with the remainder being financed with federal highway money.

# Our Fragile Earth

Even with the sometimes debilitating effects of mercury, it is not true that the mere presence of mercury implies imminent disaster. Dr. Edwin Simpson of the University of Michigan sampled fish specimens from the University's collection for their mercury content. The fish ranged from 300-2000 years in age and contained levels of mercury up to 9.5 parts per million (ppm), greatly exceeding the 0.5 ppm FDA recommended maximum. Other studies have shown human mercury concentrations to be below the maximum safe level in most localities.

In some instances it has been shown that mercury levels in humans have actually decreased in some localities. Dr. Jack Kevorkian and a team of pathologists from Detroit's Saratoga General Hospital examined preserved human tissue from as far back as 1913. They found there was actually a decline in mercury levels in most organ tissues when these tissues were compared with tissues of Michigan residents who had recently died from causes unrelated to mercury.

However, just as the studies which spurred the current controversy must be examined closely, so must these. These studies have encouraged some people to dismiss mercury as a serious environmental threat. But mercury has proven itself a serious threat simply because people have died as a result of methylmercury poisoning. Experimental results notwithstanding, this remains a pertinent fact.  
What is being done to protect the world public from the possible ravages of mercury poisoning? For one thing, some countries have banned mercury in some industrial processes. In other processes, restrictions have been placed on mercury dumping into waterways. Engineering companies are developing new ways to eliminate industrial mercury residues. People are more aware of the problem and area avoiding dangers inherent in mercury-laden products. More importantly though, the world community has become involved in the struggle.  
The Food and Agriculture Organization (FAO) of the United Nations and the World Health Organization (WHO) have addressed themselves to the problem. In several years, individual and joint meetings have provided guidance to those countries with mercury problems.  
In the U. S., no one agency has authority to place restrictions on toxic substances at every step in their environmental journey from emission to disposal. The problem of Environmental Protection Agency (EPA) does have control over several steps. The creation of EPA provided national guidance and made coordination among several other environmental agencies possible. EPA also has some influence on international agencies such as FAO and WHO. Steps have been taken; let's hope they are sufficient.

## Nature Trails

### The Owls of Our Region

Our owls seem to be getting scarcer every year, and we need more of them to help control the exploding rodent population.  
How long has it been since you have heard the deep, sonorous hoots of the great horned owl? Or the wild, weird laughter of a family of barred owls? Or the tenor tremolo of the little screech owl? It is a rare thing in some sections to hear any of these. I haven't heard the quavery tenor song of the screech owl in quite some time.  
It was a supreme delight of my boyhood to hear the late evening song of the owl, especially at some cool autumn twilight. For me, its pretty quavery tune never boded ill, as some superstitious persons believe. Some say the song of the screech owl heard about the premises foretells a death in the family. To ward off this imaginary disaster, some toss a handful of salt in the air.  
Most owls, except the barred owl, have yellow, cat eyes, which is true of the screech owl. The eyes of the barred owl are brown. There is a puzzling mystery about the two color phases in the screech owl family. Even in the same brood, there will be found red ones, the reddest of all the owls, and gray ones, the grayest of all owls, almost the identical color of white oak bark. The screech owl is the smallest one to sport ear tufts; it is a greedy eater of mice and often frequents old barns or other outbuildings in search of its favorite food. It likes to frequent old orchards and live in dead trees about clearings; it is sometimes seen in the suburbs—wherever mice may be found. The screech owl is a unique and is described as a tremulous wail, rendered in a minor key with a falling inflection.  
This small owl deserves our best protection for the good it does in destroying mice and other rodents. In a single winter, a screech owl living in a barn loft, devoured over 150 mice, as per count.  
The barred owl is so named from the cross bars on the breast. It is our largest owl, with the exception of the great horned, which is a shade larger. When seen in the woods perched on a limb during a dark, cloudy day, the barred owl presents many notable features; it seems to wear a mustache and to be entirely neckless. Its head is round and its liquid, brown eyes peer curiously at the intruder. The belly is streaked longitudinally and the predominant color is brown. It has no "horns" and is known to farmers as "the rain owl," as they believe its owl hoots predict falling weather. Its other name is "the big hoot owl," or "eight-hooter," as it gives eight resounding hoots punctuated with a "ah," at the end. Some interpret the hoots as saying, "Who—who-cooks for you—ah!"  
A family of barred owls may get together on occasion and indulge in a grand display of laughing and cackling in a weird display of owl good humor. These owls nest early in the season, mostly in February, often in a squirrel's abandoned nest.  
On dark and gloomy winter nights the big barred owl is wont to perch on some high hill and broadcast a series of doleful hoots, which may foretell more snow. No owl should ever be shot or trapped; the barred owl merits our best protection at all times, as he is a champion eater of many kinds of destructive rodents. (to be continued)

Mrs. Souleyrette will lead local volunteers in raising funds to support research and care programs for children affected by lung-damaging diseases like Cystic Fibrosis, severe asthma, chronic bronchitis, and bronchiectasis.

The Breath of Life Week will be August 17-24 with a door-to-door drive scheduled during that week.

Approximately one of every 1,500 babies is born with cystic fibrosis, which is still incurable. C-F is inherited when both parents carry the recessive gene for C-F. It is believed that one in twenty persons, or a total of ten million Americans, is a symptomless carrier of this gene. Current research funded by the Cystic Fibrosis Foundation is seeking a practical test to identify these carriers, as well as a cure for C-F and better methods of treatment for all lung-damaging diseases.

**Summer School Enrollment at PCC Shows 43.2% Gain**

A record 5,297 students are attending summer school on University of Kentucky community college campuses across the state.

The record number is a 43 percent increase over the 3,711 students who enrolled in summer school in 1974.

The overall 43 percent increase is almost exactly the enrollment increase for Prestonsburg Community College which has 128 enrolled this summer—38 more than a year ago.

"This is indeed a significant increase in our enrollment," said UK President Otis Singletary. "Only in 1965 and 1968, when we opened several new campuses did our growth rate ever approach what we have recorded this summer. I think this growth is strong evidence that our Community Colleges are fulfilling a critical need in Kentucky."

The largest percentage increase in enrollment occurred at the Jefferson Community College Southwest campus, where enrollment of 346 students was almost triple that of last summer.

A 170.2 percent increase was recorded at Madisonville Community College, where 254 students are enrolled, compared to last year's 94. Other campuses experiencing major increases were Mayesville (55.7 percent), Hopkinsville (52.0 percent), Somerset (49.0 percent) and Prestonsburg (48.2 percent). Only Hazard Community College showed a loss.



# What To Do In July

By NEVILLE SHAKELFORD (UK College of Agriculture)

July in the north temperate regions, is likely to be the hottest month of the year and the month in which summer reaches maturity. Under the burning sun, grass in the fields and leaves on the trees begin to lose the freshness and greenness of June and, in the swamps, the male crickets begin their melancholy dirges that presage the coming of fall.

Garden flowers thrive in July and many of the most brilliant of them are in their prime. The dahlias, sweet peas, nasturtiums, and touch-me-nots are in full bloom. The air is full of the hum of insects, birds dart everywhere in search of the insects, and over the cottonball blooms of the milkweed, monarch butterflies swarm by the dozens.

In the vegetable garden, there is great and good activity. Tomatoes, cucumbers, and green beans are busily ripening on the vine. Golden ears of sweet corn protrude from the stalks begging to be eaten. All in all, July is a month of abundant life and a season in which to take a "rest" after all the furious activities of spring.

July is the month in which to sit on shady porches and pick the teeth after a hearty noonday meal of blackberry cobbler, corn on the cob, cornbread, and some of the other good things ripening in the garden. It is the month in which to go swimming in the old mill pond and to hunt wild huckleberries to make some of the best preserves known to man. And it is the time to attend local farm field days and county fairs.

July is a fine time, too, in which to visit land-grant college Experiment Stations and observe what is being done to develop new and improved plants, better livestock, and more efficient farm equipment, and in general, what is being done to make for a better way of life for the farmer and everyone else. There are events scheduled by the University of Kentucky College of Agriculture this month offering excellent opportunities for such visits—Beef Cattle Day at Coler and stream and Maine Chance Farms near Lexington, on July 10; Farmers' Research Information Day at UK's West Kentucky Substation, Princeton, on July 17, and July 25; an Ornamentals and Home Gardens Open House on the UK campus in Lexington. Details on these happenings are available at county Extension offices.

Coming as it does in that lush between the fury of spring planting and the rush of the harvest, July is a month ideal for rest and recreation. It is a month ideal for picnicking, horseshoes, playing marbles, and watching ball games on TV. There are, however, some things that can very well be done during the month to improve the old homestead.

A gardener with a little energy, left over from May and June can watch out for peach tree borers and take action recommended against them by his county Extension agent. He can begin to sow cover crops between rows in the corn patch and in vacated plant beds. He can plant a late patch of beans and sow radishes, turnips, and mustard. He can mulch to protect plants from drought and from the intense heat that can slow down growth.

Except for one thing a gardener can get by without too much work in July. The exception is insects. Injurious garden insects seem never to take a breather and, if one would have a continuous flow of garden truck, insects must be controlled. With this unfortunately being the case, the war against bugs must go on, even in July. Despite its heat, often violent thunderstorms, and sometimes drought conditions, July is a good month. It is a month in which gardeners start reaping the best results of their labors. These results are what gardening is all about. Don't fail to take time out to enjoy them.

# Some Who Fought on Freedom Trail

 Much ado is being made about the early days of our country. Material gathered from genealogical records shows that many of these persevering and brave pioneers not only helped America gain independence, but made paths into Kentucky, helping the Commonwealth sustain a firm foundation.

Although some early graves are marked, others have been lost to weeds, time and the elements. Still, Kentucky's soldiers of the Revolution have left behind them a trail of pride. It is this trail that annually sends Americans in search of information concerning their ancestors.

The Britains (Britons), for example, settled in various Eastern Kentucky locations following the war, with descendants of James Brittan buried in Harlan, Knox, Rockcastle, Barren, Clay and other counties.

James Brittan, a lineal descendant of Sir William Brittan, was born in 1709 in Wales and later immigrated to America. He left Virginia for North Carolina and became the father of seven sons. Among them were Nathaniel and William, who both served in the war. Nathaniel died in service in the Eighth Virginia Regiment. Nathaniel's son, Gen. George Brittan, fought in the War of 1812 and died in Harlan County.

Information, much of it supplied by Henry P. Scaif of Stanville through his publication "The East Kentuckian," states that Pete Hanks was a soldier of the Revolution, later moving to Wolfe County.

Other veterans mentioned in his genealogical quarterly include the following:

Moses Stepp, of the South Carolina line, was born in 1725 and died in Martin County in 1855 at the age of 120.

Jan Schmidt Baisden came from his

native Belgium to fight under Lafayette. He later settled in Floyd County.

William Howerton was born in Virginia in 1759. After fighting in the Revolutionary War, he moved to War Creek in Morgan County.

John Faubus was of French extraction and after the war settled at Pond Creek in what is now Laurel County. A descendant, Orval Faubus, became governor of Arkansas.

John McGuire, who was born April 22, 1756 in Ireland and died April 10, 1837 in Morgan County, enlisted twice in the army. In July, 1780 he entered service under Capt. Keller and Col. Benjamin Logan in Virginia. In September of that year, he again enrolled in Mercer County under Capt. Gordon, who was killed at the Battle of Blue Licks.

Alden Williamson, a native of Virginia, was the son of Hugh Williamson of Wales and served in the Fincastle County battalion. The younger Williamson fought in the Battle of Point Pleasant in 1774 in Robert Daak's Company of Militia. He moved near Prestonsburg in

1801 and died on a raft of logs on the Tug River in 1816 at age 66.

John Day also served in the Revolution and—in 1810—he and his wife, the former Rebecca Howe, moved to what would become Morgan County. Day's mother, Susan Wyley Day, was killed by Indians in Botetourt County, Va.

David Bengo who died in Clay County in 1854 was born in 1760 in Virginia and served in both the Revolutionary War and War of 1812.

Jesse Brock of Virginia died about 1836 in Harlan County. He served in the North Carolina Militia. Elijah Brock, a great grandson, said Jesse's father, Aaron Brock, was half Indian and his mother full Indian. His sister Polly married Revolutionary War soldier Ephraim Osborn (Sr.), who also died in Harlan County in 1822.

Daniel Davis' son, of Virginia, who served with Daniel Morgan's crack riflemen, later settled and died in Clay County. His brother, George, married Mary Woods and became the ancestor of William Jennings Bryan.

## Environmental Rules Adopted

Frankfort, Ky.—In the midst of the longest air pollution alert ever in Kentucky, the state's revised air pollution regulations were adopted.

It won't help clean up the air stagnation. But, many people may breathe a little easier since the state would have been left without any air pollution regulations if they had been rejected by a legislative review committee.

The same goes for the state's water quality and reclamation regulations. The state wouldn't have had any regulations governing water quality or reclamation if the legislative review committee had rejected them at its recent meeting.

A law passed by the 1974 state legislature required all state agencies to readopt their regulations by July 1 or have them rescinded.

The only objections raised before adoption of any of the regulations of the Kentucky Department for Natural Resources and Environmental Protection concerned air pollution. Some of those objections echoed those raised at a public hearing last April.

Those objections were to the use of a computer modeling system to classify air quality regions and to the elimination of using alternate control strategies in lieu of direct emission controls. Industries in regions classified as the most highly polluted must control their emissions more than those in the other regions.

At the public hearing, most objections came from persons connected with power companies—TVA, East Kentucky Power Cooperative, Kentucky Utilities Company, Kentucky Association of Electric Cooperatives and the plant boards of several towns.

The objections almost prevented adoption of some of the proposed revisions. However, after a noon recess, the major objections were dropped.

The only question raised about water quality regulations was about a regulation that wasn't changed—the state's controversial stream classification system. However, John S. Hoffman, secretary of the environmental

protection agency, said the department was reevaluating that regulation and urged its adoption, since the state would be left without any stream classification system if it were rescinded.

No questions were raised about reclamation regulations; however, the controversial new regulations dealing with the surface effects of underground mining weren't before the legislative review committee for adoption.

Also approved was a regulation dealing with certification of water and waste water operators. All other regulations of the division of sanitary engineering had been adopted by the legislative committee at a May 14 meeting.



**Air Pollution Alert Called**

FRANKFORT, Ky.—Kentucky has been in the midst of its longest and most serious bout with California-type smog. The culprits are stagnant air and oxidants that combine to form photochemical smog.

On Wednesday, June 25, the U. S. Weather Bureau issued an air stagnation advisory for northern and central Kentucky—an area that experiences windless air stagnation 2 to 20 days a year.

Monitoring of the air was stepped up by the division of air pollution in the Kentucky Department for Natural Resources and Environmental Protection. Higher than normal levels of ozone—a constituent of photochemical smog—were recorded in the Louisville, Lexington and Covington-Newport areas.

By Friday, the ozone levels were approaching alert stage. At 2 p.m., Friday, the division issued an air pollution alert for the three large metropolitan areas. According to John T. Smither, director of the air pollution division, the alert is geared to curtailing activities that produce hydrocarbons. Hydrocarbons, which combine sunlight to form photochemical oxidants and ozone, are produced by driving cars and by using solvents such as those used by paint manufacturers.

The alert advises that driving be voluntarily reduced, that use of public transportation be increased and that persons who have respiratory or heart ailments stay indoors, in an air-conditioned building if possible.

According to Smither, there is a daily reprieve from the high ozone levels when the sun goes down, since ozone is formed in the presence of sunlight. However, the ozone buildup begins again at about 10 or 11 the next morning as long as the air stagnation persists.

Smither said the air pollution alert will probably last as long as their air stagnation advisory remains in effect. Already the alert is the longest ever issued by the division.

In the three years since the state clean air division set up the alert procedure, only one other alert has been called. A year ago, an alert was issued for the Ashland area. That alert—brought on by stagnant air and high levels of particulate matter (soot)—lasted only one day.



**Marking of Personal Property Urged As a Burglary 'Defense'**

Frankfort, Ky.—State and local police are launching a statewide campaign, urging Kentucky homeowners to mark their personal property with an identifying number as "one good defense" against the state's high rate of home burglaries.

Already practiced on the local level in several scattered jurisdictions across the state, "Operation Property Identification"—as it is being called—advocates that police and civic groups loan etching tools to citizens so they may inscribe their social security or driver's license numbers on property items of value at home or their places of business.

If property is stolen and subsequently recovered by police, the identifying number both insures the return of the property to its rightful owner and improves the chances for successful prosecution of the thief.

Adoption of the program on a statewide basis recently was announced here following the first strategy planning session of the newly organized Kentucky Office of Crime Prevention (KOCP) and a special advisory committee appointed by Gov. Julian Carroll to study ways and means of combating rising crime rates in Kentucky.

In a speech delivered before a meeting of that committee late in April at Louisville, Carroll gave "Operation Property Identification" top priority in a suggested list of eight crime prevention measures.

According to two spokesmen for KOCP and the special committee, more than 300,000 Kentucky homeowners will be contacted by state and local police over the next 12 months and offered the use of the etching tools.

Jefferson County Police Detective Robert Payton, who also serves as advisory committee chairman, described the campaign as potentially being one of the best safeguards against property theft.

"If people will only cooperate with their local and state police in getting their property engraved with appropriate serial numbers, the average burglar will not want to risk the chance of getting caught (by stealing it)," he said.

Payton added that the number of homeowners to be contacted by police during the next 12 months represents more than one-third of the state's total homeowners population. They also are potential targets for better than 36,000 burglaries over the next year as well, he said.

State Police Capt. William O. Newman, named by the governor to head KOCP, said that the cost of additional etching tools needed for the campaign will be paid out of funds awarded late in May to KOCP and the advisory committee for

## Consumer Comments

**By Atty. Gen. Hancock**  
Some people furnish their homes or apartments in "Early American" and others prefer "Old Attic" (also known as used furniture). Whatever type of furniture you buy, new or used, learn to examine it carefully before you make your purchase.  
Always begin by checking the framework, to see how well something is put together. A good quality frame won't creek or give when you push against it. If you are looking at something with drawers, pull them out and examine the inside corners of the chest frame. Wood corner posts are a sign of good quality. The drawers should pull out smoothly, and the sides and bottoms of drawers should be solid. When closed, drawers should fit squarely in the openings.

If you are looking at a table or chair, be sure the legs are securely attached. Does the piece of furniture stand evenly on the floor?  
Upholstered furniture pieces make an examination of the framework a bit more difficult. The outer covering of upholstered furniture should hang smoothly. Examine the fabric for durability and ease of care.  
The cushioning material of upholstered pieces may be of several types. Cellular foams, called urethane or polyfoam, are distinguished by their resistance to wear, their nonallergenic quality, and their moistureproof characteristics. Latex foam

rubber, another kind of filling, has great resiliency and comfort. Find out what's inside.  
Wooden furniture includes both hardwoods and softwoods. Always ask if a furniture piece is solid or veneer. Veneering is the process where a fine quality wood is used as an outer layer in a kind of plywood sandwich. Veneering makes it possible to simulate high quality woods at a lower cost, and is usually less susceptible to cracking, warping, and swelling than solid wood furniture.  
Finishes add beauty and wearability because of the color they give and the protection against moisture they offer. But when you see "genuine mahogany finish," remember there is a difference between a genuine mahogany table (solid mahogany) and genuine mahogany finish (the wood is treated to look like mahogany).

## Auxier Road Gas Co. Reduces Gas Rates

Customer rates for gas supplied by the Auxier Road Gas Company, Inc. were decreased, effective July 1, according to a recent order of the Kentucky Public Service Commission (PSC).  
Rates for gas supplied to Auxier by Columbia Gas of Kentucky, Inc. were decreased as of that date. PSC Secretary Richard D. Heman said the effect of the order is to pass the savings on to consumers.  
The total decrease in wholesale rates for gas will amount to approximately four cents per thousand cubic feet.

Herman said that the reduction in rates results from application of the same "purchased gas adjustment" clause responsible for recent rate increases.  
The "purchased gas adjustment clause" allows utilities to maintain a reasonable return while compensating for increases or decreases in the cost of purchased gas.

## Workmen Find Women's Head At Paintsville

Discovery by workmen Monday morning at Paintsville of a woman's head was followed by officers' attempts to determine if murder had been committed or a grave had been robbed.  
The grisly find was made as workmen were cleaning a parking lot near the new restaurant constructed in the vicinity of the Paintsville Stockyards. The head rolled out of a plastic garbage bag as one of the workers prepared to burn it.  
State Police Detective Jack Musick and the Johnson county sheriff's department are investigating the case. The head believed to be that of a woman between 40 and 50 years old, was taken Tuesday to the UK Medical Center, Lexington, for laboratory tests to determine if the body had been embalmed.  
Acting Coroner Bill Phelps said that if the body was originally embalmed, death may have occurred as long as three years ago, if not, possibly six months ago. The head was in a fair state of preservation, still retaining facial tissue, hair and teeth.

No identity has been established. No woman is known to be missing in Johnson County, and there has been no reported case of grave robbery.  
Authorities said an apparent attempt to sever the head of the jaw had been made with a knife. That falling decapitation was made by cutting or sawing at the neck.  
Officers theorized that the head was left at the parking lot Sunday night or early Monday morning. Other parts of the body have not been found.

### TURNPIKE TOLL ENDS

Monday, June 30, marked the end to toll collection activities on the Kentucky Turnpike. The order ending toll collection came 19 years ahead of schedule. The 40-year revenue bonds issued in 1954 in the amount of \$38,500,000 to finance the turnpike construction costs have been paid off.

## Hearing Continued On Fishtrap Road

A federal court hearing in the case of the Crescent Coal Co., which has been ordered to stop construction of an access road near Fishtrap Lake, was continued last week till Monday in Catlettsburg.  
A spokesman for the U. S. attorney's office said the continuance was granted by agreement of both the plaintiff and the Elkhorn City firm.

The hearing concerns a temporary restraining order, issued in U. S. District Court in Lexington about two weeks ago, prohibiting Crescent Coal from further road construction near the Grapevine Creek recreation area of Fishtrap Lake in Pike county.  
The order was issued on behalf of the Army Corps of Engineers, which owns the road site and developed the Fishtrap dam and lake in the late 1960s.

The Corps is seeking a permanent injunction against Crescent, as well as "mandatory relief" from what it says is a hazardous situation created by the construction.  
Corps spokesmen in Huntington, W. Va., said construction of the road, which would be used to haul auger-mined coal, has caused large boulders to fall into the four-acre recreation area.

The Corps had closed the Grapevine facilities, which include picnic tables, campsites and launching ramps, while construction of the road was in progress.  
The spokesman also said the Corps opposes the road because of the "competition" it would create between coal trucks and lake visitors.

## Plane Crash Claims 2 Lives

Dr. Ray C. Haley, 56, head pathologist at the Methodist Hospital, Pikeville, and Donald D. Sloan, manager and flight instructor at the Pikeville airport, died almost instantly Saturday when the 1943 model plane in which they were flying crashed at the edge of Lake Helen, a small, commercial impoundment near the airport.

Eyewitnesses told Pike County Coroner Bradford Hall that the plane had travelled perhaps 500 feet after takeoff when it apparently developed engine trouble. The plane then changed direction, veering south, heading back toward the airport. An attempt may have been made to land on the lake, it was theorized, but the craft rammed into the bank instead.

The coroner said Dr. Haley's position in the plane indicated he was piloting it at the time of the crash. Sloan was thrown clear of the wreckage but the doctor's body was found in the plane.

Dr. Haley was widely known in this section and was frequently called upon by officials to perform autopsies.



State Unemployment Drops, Floyd Near Kentucky Average

FRANKFORT, Ky.—Unemployment in Kentucky fell four tenths of one per cent in May, according to figures released last Thursday by the Department for Human Resources (DHR). The state unemployment rate now stands at 7.2 per cent.

Floyd county's unemployment rate is 1 per cent above the state average. "Although unemployment statewide dropped in May, there were increases in the Louisville, Lexington and Owensboro areas," said Robert MacDonald, labor market analyst for DHR.

"The decrease is due to seasonal hiring in industries such as lumber, clothing, agriculture and service (vacation, and tourist-oriented) industries," MacDonald continued. None of these industries are located predominantly in the three metropolitan areas where unemployment increased.

The May figures show 17 counties with over 10 per cent of the labor force unemployed. This compares with 32 counties in April in the same situation.

## Traffic Speeds Climb State Police Report

Frankfort, Ky. — A high-ranking state police official has declared that the 15-month-old 55 m.p.h. speed limit is "still having some effect" in Kentucky, although the average speed of both cars and trucks has climbed in recent months.

Col. James H. Mayes, commander of State Police Administration and Services, praised Kentucky's safety and enforcement record since the 55 m.p.h. law went into effect March 1, 1974 in a report he prepared for the American Association of Motor Vehicle Administrators.

"Voluntary compliance, prompted by immediate public information and a sound enforcement program, has had a distinct safety effect upon Kentucky's

total traffic system," Mayes said.

Mayes said the new speed limit was largely responsible for a significant decrease in highway fatalities last year—a decrease of 29 per cent over 1973, from 1,117 to 795. Only one other state recorded a bigger decrease.

Kentucky also recorded its lowest highway death rate ever in 1974. The death rate of 3.3 for every 100 million miles of travel placed the state below the national rate of 3.6, the first time Kentucky ever has produced a lower rate than the nation's.

But highway fatalities are up in 1975, and a table Mayes prepared showing average speeds of trucks and cars at five different intervals since 1973 indicates that motorists are steadily speeding up.

Although Mayes reported that the state police spent two per cent less time on traffic-related duties in 1974 as compared to 1973, the "overall traffic enforcement program with some emphasis on the enforcement of speed" has produced large increases in speeding citations, driving-while-intoxicated (DWI) arrests and other measures of traffic control.

For example, speeding citations jumped from 3,140 in February of 1974 to 11,081 in March. There was a record total of 232,155 traffic tickets (for all violations) written last year, up from 182,933 the year before.

In other categories, DWI arrests increased from 12,270 in 1973 to 14,408 last year, speeding citations, 61,230 to 107,517, reckless driving decreased from 20,915 to 16,271; traffic accidents declined from 92,262 to 81,130.

In the last five years, the number of licensed drivers and registered vehicles has steadily increased. The number of motorists has grown from 1,620,000 in 1970 to 1,960,183 last year while vehicles have increased from 1,815,437 to 2,350,000.

Among hardware used in the state police traffic enforcement program are 24 radar units, 42 radar units, 25 "speed guns" and two aircraft with six pilots.

### Voc Education Gets \$400,000 ARC Grant

The Appalachian Regional Commission has approved a grant of \$400,000 for the operation of vocational education projects in the Appalachian section of Kentucky.

The funds will be used for vocational programs and services offered in five state vocational-technical schools, 11 area vocational centers and one correctional institution.

Vocational education projects provide training opportunities for secondary and post-secondary students and employed adults and offer job placement on completion of training.

The ARC also has approved a grant of \$400,000 for the construction of an addition to the St. Clair Medical Center in Morehead. The grant will be used in the construction of a 20-bed psychiatric unit and in the expansion of emergency, laboratory, radiology and respiratory therapy services. The expansion will make the medical center a major inpatient referral facility for Cave Run Mental Health Center. A survey taken in 1974 indicates that 40 patients a month would have used a psychiatric unit if available.

Total cost of the project is approximately \$1.2 million. The National Institute of Mental Health will provide approximately \$240,000. Local sources will provide \$569,361.

Roberts said Monday night that he is joining National Mines Corp., of Lexington. His resignation is effective July 15. Roberts said he will be in charge of environmental control for National Mines.

"I just had this opportunity come up last week," Roberts said, adding it meant such a boost in pay that he could not turn it down.

Roberts said his resignation did not reflect any dissatisfaction with the department's policies, but was just simply a matter of "economics."

He is the third head of an control pollution agency to resign from the department within a week.

Last week Herman D. Regan, commissioner for environmental quality, and Harold T. Snodgrass, director of the Division of Water Quality, resigned also effective July 15.

Roberts said his resignation was in no way related to those of Regan and Snodgrass. The two said they were quitting to start an environmental consulting firm.

## July 18 Workshop To View Problems Of State Schools

Pupil dismissal and suspension from school and due process, weighty matters which are causing educators and school administrators growing concern, these days, will be discussed at a regional workshop here July 18.

Samuel Alexander and Ray Corris, of the State Department of Education, will discuss expulsion and suspension of pupils. They will explain recent cases, school board policies relating to student behavior, what due process is and when a school superintendent, principal or board members are liable.

Situations will be staged at the workshop to show proper and improper handling of individual cases, and group meetings will be held to formulate school policy on expulsions and due process.

Another task for the group will be the drafting of a model letter to parents and children in cases of expulsion or suspension.

Announcement of the workshop was made by the ROPES' Region II office.
